Many are found in society the behavior of teenagers who behave badly such as Bullying, Brawls, Illegal Drugs, Free association, and many more. However, for the discussion of this article only take a few examples related to the behavior and social deviations in teenagers that commonly occur in the society around us.

Juvenile delinquency today is increasingly concerning and diverse, ranging from minor delinquency, to serious acquaintances and even entering the category of violations of the law. As has happened recently, namely juvenile delinquency in the form of brawls and prostitution that occurred in Surabaya, it was a heavy blow to the community, especially educators because the perpetrators were still junior high school students. Even the perpetrators were able to organize their peers in conducting prostitution business among teenagers.

Juvenile delinquency is a complex and multidimensional social problem, involving various factors that interact with each other. This problem not only affects the individual teenagers involved, but also affects families, communities, and society as a whole. One of the teenagers who committed juvenile delinquency in the surrounding environment was "Most of us have done it all, but not all of them turn into addiction. Like me, I'm just a heavy drinker, sister. Young people in my village often drink alcohol because it's our culture. Drugs, but if only young people drink it, not all of them, right, Sis."

Free association is a social deviant behavior that has quite a negative impact on society, especially teenagers. because in addition to violating community norms, this behavior can also violate religious norms. This is because free association can lead to immoral behavior that is rampant in adolescence.

Juvenile delinquency in the surrounding environment is not only consuming alcohol, but here there are also some teenagers who consume koplo pills, drug users and dealers. In addition, there are still other juvenile delinquencies in Kampung Barutikung including brawls, glue sniffing, and stealing things at school, but only a few teenagers commit this juvenile delinquency (Ibrahim, B., & Mensah, H. 2022).

The following is the result of an interview conducted with Mrs. EN " Juvenile crime in Barutikong Village is not as bad as other areas around Barutikong Village. The crimes committed by young people here are staying home late at night and drinking alcohol, things that young people often do."

Similar things were also expressed by Mr. L, Mr. S and KW, "Children and teenagers in different places are guilty of the same thing, sister. However, because our environment has long been known as an environment with high levels of crime and juvenile delinquency, our environment is different from most. The bad habits of children in this village include drinking alcohol, going out at night, fighting because they are bullied by third parties, even teenagers who are arrogant and use or drugs such as crystal methamphetamine and teenagers who distribute these drugs. we are under police supervision so that the distribution of illegal substances among teenagers has decreased slightly."

Juvenile delinquency is caused by many factors ranging from individual factors and external factors. These individual factors come from the teenagers themselves. External factors come from many factors including religious factors, family factors, adolescent home environment factors, social factors, and social media factors which are currently growing rapidly (Arias, E., Arce, R., Vázquez, MJ, & Marcos, V. 2020).

# Modern Society and Juvenile Delinquency: A Social Study

As is known, crime is a different type of society and violates moral values, social values, true religious values, and several important aspects in it, including the existing legal system, which occurs in, unwritten rules and different behaviors for the younger generation will be useful in shaping the character of the younger generation and realizing its potential.

And the non-implementation of religion in everyday life by both individuals and society. The causes of juvenile delinquency in general include (Castro, C., Doncel, P., Dinu, AI, & Padilla, F. 2023):

## Lack of Role Models from Parents

The most important role model for their children is the interaction between the father/mother and siblings, sports, and their environment. Children are affected by parental violence in various ways. If parents do not set a good example in behaving well, then these traits will hinder the child's moral development, namely through imitation, because parents are the closest people and they meet every day.

# Lack of Religious Education in the Family

Often parents assume that education is only provided at school because it is not needed at home, even though parents do not realize that their children stay at home longer at school, but their working hours are limited. And if parents think religious education is not important, then general education is more important.

Children who receive religious teachings can provide a solid foundation for the child's future moral and lifelong development. On the other hand, if a child does not receive religious teachings from the family, then he no longer feels that he has no control over his actions, sins or sins.

## **Lack of Parental Attention**

Zai and Wani (2024) suggest that financial problems drive young people to look for quick ways to make money, including engaging in illegal activities.

## **Efforts to Combat Juvenile Delinquency**

Nakagomi, S. (2012) explains that there are several things that can be done to reduce the occurrence of delinquency in adolescents as follows:

## Curative efforts

Curative efforts are anticipation of symptoms of delinquency, so that delinquency does not spread. Treatment is waiting for evidence of a crime, so that treatment is carried out by the Police and the Prosecutor's Office. Because juvenile delinquency has an impact on oneself and society. Crime and other crimes.

# Coaching efforts

Coaching efforts are intended to; (1) Guidance for teenagers who have experienced delinquent behavior or who have undergone a punishment for their delinquency. This needs to be guided so that they can not repeat their delinquency; (2) Guidance for teenagers who do not commit delinquency is carried out at home, school, and in the community. Guidance like this has been expressed in previous preventive efforts.

#### Preventive measures

At home, including; (1) Creating a harmonious family environment; (2) There are similarities between family norms in educating children; (3) Providing adequate attention to children's needs; (4) Provide reasonable supervision of children's social interactions; (5) Creating a religious environment (Miyako Oulevey, David Lavallee, Yasutaka Ojio, Naohiko Kohtake, 2024); (6) In society

Education in society is often ignored by some people because they assume that education is enough at school.
